— 2021 HONOREES TO BE ANNOUNCED SOON —

Each year, MHAS honors 2-3 individuals and/or companies who are making outstanding contributions to the field of mental health advocacy.

Honorees for the Jim Preis Memorial Award and Advocates Award will be announced in the summer of 2021.

In 2020, MHAS presented the Jim Preis Memorial Award to Former Congressman and Mental Health Advocate Patrick J. Kennedy and the Advocates Award to Author Esmé Weijun-Wang. MHAS was proud to honor their achievements and contributions to improving the lives of people with mental health disabilities.



Mental Health Advocacy Services is a legal services nonprofit organization whose mission is to protect and advance the legal rights of low-income adults and children with mental health disabilities and empower them to assert those rights in order to maximize their autonomy, achieve equity, and secure the resources they need to thrive.

WHAT WE DO

Our primary areas of service include:

- Public Benefits
- Fair Housing
- Expungement
- Consumer Finance
- Homelessness Prevention

In 2020, MHAS provided free legal advice and/or representation to over 3,000 low-income clients who would have otherwise been unable to afford an attorney.

MHAS also provided more than 100 trainings to over 1,500 attendees, equipping them with information about mental health disability rights, community resources, and pandemic-related protections and services.

MHAS also participates in **impact litigation and policy advocacy** in an effort to improve the lives of people with mental health disabilities.

CHAMPIONS LIVE HERE

In June 2021, The Los Angeles Super Bowl Host Committee recognized MHAS as one of 56 "unsung hero" nonprofits who are making a transformative impact in underserved communities across Los Angeles.

The award includes a \$10,000 grant and a professionally produced video that will help raise awareness of MHAS' mission.

WHO WE SERVE

MHAS serves low-income adults and children with mental health disabilities who reside in Los Angeles County.

Of the clients served in the past year:

- 75% identify as people of color,
- 36% lack stable housing, and
- 83% are 18-64 years old.

HOW WE DO IT

Recognizing that systemic racism is embedded in all aspects of the civil legal system, MHAS engages in racial justice work every day in its fight to preserve and expand access to health, housing, economic opportunity, and justice for low-income individuals living at the intersection of race and disability.

MHAS further partners with local mental health and health care providers, social workers, and other community-based organizations to provide holistic, client-centered, and trauma-informed legal services.



At 21-years-old, Clara is balancing motherhood, mental health disabilities, and several legal battles. She is a survivor of intimate partner violence and is in proceedings with the child welfare system to maintain parental rights of her young children. Clara herself grew up in the same system and is actively

WHY CLARA CAME TO MHAS

Clara was referred to MHAS after her landlord:

Unlawfully evicted her while pregnant and during the pandemic,

working to provide a better and more stable life for herself and her young children.

- Damaged her property,
- Refused to return her security deposit, and
- **Sued her in small claims court** seeking \$800 in unpaid rent from months <u>after</u> the wrongful eviction.

HELPING CLARA DEFEND HER CASE

Because clients appear in small claims court without an attorney, MHAS helped prepare Clara to defend her case alone. With MHAS' guidance, Clara successfully advocated for herself at the small claims hearing. The judge ruled that Clara's tenancy rights were entirely violated and went on to award her more than \$725 in damages for her counterclaims.

WHAT'S NEXT FOR CLARA

MHAS' advocacy empowered Clara and gave her the footing necessary to not only avoid wrongful and abusive debt, but to also begin to rebuild her life with the funds she was awarded. Clara is now connected with a local intimate partner violence organization to continue working toward a safer future for herself, and to one day regain custody of her children.
